
"Triple Safety Policy"— "safe work," "safe workplace," and "safe labor"

- 4. Assisting industries in risk control, and promoting labor-management harmony and public safety




2022 Fatality Ratios by Injury Types in SOI*

NON-FATAL OCCUPATIONAL INJURY RATE




Non-Fatal Occupational Injury Rate (per 100,000 workers) = Non-Fatal Occupational Injuries Number of Workers X 100,000
