Subsidies for assistive devices under the Labor Occupational Accident Insurance and Protection Act

- 1 Subsidies for assistive devices listed in the Attached Table of Article 3 of the Regulations for Occupational Accidents Workers to Apply for Device Care Disability and Death Subsidies
 - Persons previously insured under the Labor Occupational Accident Insurance and Protection Act who have previously worked in specific hazardous jobs
 - Diagnosed by a physician or assessed by a professional to need assistive devices
 - Apply for subsidies after purchasing or renting assistive devices
 - Each person may receive up to NT\$100,000 in subsidies for 4 items
- 2 Subsidies on a case-by-case basis when the assistive devices listed in the attached table do not meet needs
 - Persons previously insured under the Labor Occupational Accident Insurance and Protection Act who have previously worked in specific hazardous jobs
 - Diagnosed by a physician or assessed by a professional to need assistive devices
 - Fill out an application form to apply to the Occupational Safety and Health Administration
 - Review by the Occupational Safety and Health Administration on a case-by-case basis
 - Purchase or rent assistive devices within 6 months of approval
 - Submit invoices or receipts to the Occupational Safety and Health Administration for reimbursement of up to NT\$100,000 per person per year

I. Subsidies under the Act for Protecting Worker of Occupational Accidents

Workers in occupational accidents between April 28, 2002 (when the Act for Protecting Worker of Occupational Accidents took effect) and April 30, 2022 who have already claimed or chosen to claim occupational accident benefits from labor insurance.

1 Occupational disease living subsidies

- Diagnosed to have an occupational disease
- Level of disability: Level 1 to Level 15
- A monthly subsidy from NT\$2,100 to NT\$9,200, depending on the level of disability
- Enrolled in Labor Insurance: Up to 5 years
Not enrolled in Labor Insurance: Up to 3 years

2 The Disable living subsidies

- Suffered an occupational injury
- Level of disability: Level 1 to Level 7
- A monthly subsidy of NT\$6,600 or NT\$9,200
- Enrolled in Labor Insurance: Up to 5 years
Not enrolled in Labor Insurance: Up to 3 years

3 Assistive device subsidy

- Involved in an occupational accident
- Assessed by a physician or professional to need assistive devices
- Apply for subsidies after purchasing assistive devices
- Each person may receive subsidies for 4 items up to NT\$60,000

4 Care-taking subsidy

- Involved in an occupational accident
- Permanently unable to work
Type of disability: Mental, neurological, thoracic and abdominal organs, skin
Level of disability: Level 1, Level 2
- A monthly subsidy of NT\$13,100
- Enrolled in Labor Insurance: Up to 5 years
Not enrolled in Labor Insurance: Up to 3 years



5 Survivors' subsidy

- Death due to an occupational accident
- Survivors: Spouse, children (first priority), or parents (second priority)
- A subsidy of NT\$100,000



6 Occupational disease living subsidies after withdrawal from labor insurance

- The insured withdrew from insurance after April 28, 2002
- Diagnosed with an occupational disease but did not receive disability benefits
- Level of disability: Level 1 to Level 15
- A monthly subsidy from NT\$2,100 to NT\$9,200, depending on the level of disability
- Up to 5 years

7 Disability subsidies

- Workers not enrolled in Labor Insurance involved in an occupational accident between April 28, 2002 and April 30, 2022
- Level of disability: Level 1 to Level 10
- The employer failed to provide disability compensation in accordance with the Labor Standards Act
- Payment standard: Disability subsidies will be paid for 330 to 1,800 days based on the minimum monthly insured salary of Labor Insurance at the time of disability
(If the employer has paid compensation, that amount must be deducted)

8 Death subsidy

- Workers not enrolled in Labor Insurance involved in an occupational accident between April 28, 2002 and April 30, 2022
- Survivors: Spouse, children, parents, grandparents
Dependent grandchildren and siblings
- The employer failed to provide death compensation in accordance with the Labor Standards Act
- Payment standard: A death subsidy equal to 45 months of the minimum monthly insured salary of Labor Insurance at the time of death will be paid
(If the employer has paid compensation, that amount must be deducted)
